CIRCULAR

Subject: Extension in time period for carrying out new amendments as per Multi-State Cooperative Societies (MSCS) (Amendment) Act & Rules, 2023 -reg.

In view of the Multi-State Cooperative Societies (MSCS) (Amendment) Act & Rules, 2023 notified vide gazette notifications dated 03.08.2023 and 04.08.2023 respectively, a circular of even number dated 16.10.2023 (copy enclosed) was issued by this office to request all multi-State cooperative societies to amend their existing bye-laws in line with the amended Act & Rules, 2023 and to submit amendment proposal through the CRCS portal (<https://crs.gov.in/>) within six months from the date of issuance of circular.

2. To facilitate the process of amendment of bye-laws for MSCSs, three templates of bye-laws for different types of MSCSs, namely Credit (including multi-purpose having credit & thrift activity), Non-Credit, and Federal Multi-State Cooperative Societies were also circulated to serve as reference points.

3. In the meantime, several requests have been received from some MSCSs to give an extension in time period for carrying out new amendments as per amended Act & Rules 2023.

4. In view of above, it has been decided to extend the time period for carrying out new amendments as per amended Act & Rules 2023 by all the MSCSs till 30.09.2024.

5. In case of any conflict, the provisions of MSCS Act and Rules shall prevail over the bye-laws.

The Multi-State Cooperative Societies (MSCS) (Amendment) Act, 2023 has been notified vide gazette notification dated 03.08.2023 and the MSCS Amendment Rules, 2023 have been notified vide gazette notification dated 04.08.2023.
